Battery Critical Definition – Battery alarm generated when there is approximately 6+ hours battery operation time remaining on an active ReliAlert™ device. \*NOTE: there is a previous “Battery Low” event that automatically notifies the Monitored Individual via device vibrations.

Battery Critical Escalated Definition – Battery alarm generated when there is approximately 1.5-2 hours battery operation time remaining on a on an active ReliAlert device.

Sleep Mode Definition - Sleep Mode occurs before a device shuts down completely due to failure to properly charge. While in Sleep Mode the device retains enough battery life to "wake up" every 6 hours and attempts to obtain a GPS trace. This can occur for up to 2 weeks before the device shuts down completely.
